Please Note:

1. If you fail to appear for the interview as per the above schedule due to whatsoever reasons, your candidature for the above post will be treated as cancelled.
2. You should **bring a print out of the application, filled online, for Interview with photograph** similar to the one which was furnished at the time of applying for the CWE duly pasted thereon along-with the following certificates/documents, in **original**, for verification at the time of the interview, and also one set of photo copy of each of the certificates/documents duly attested by a Gazetted Officer, in support of your candidature for the above post, arranged in the order set out hereunder:
 - a) Original fee payment receipt (CBS challan).
 - b) Print out of the application, filled online, for Interview.
 - c) Printout of your IBPS Scores for the stipulated examination.
 - d) Attested copy of Matriculation certificate/Birth certificate issued by the Municipal Authority, as proof of age.
 - e) Attested copies of Mark-sheets/certificates in support of Educational Qualification;
 - f) Attested copy of certificate of a Computer Course done, if any;
 - g) Certificate of SC/ST/OBC/Person with Disability (whatever applicable) in the prescribed format.
 - h) Photo Identity proof and Address Proof.
 - i) Candidate serving in Government/Public Sector Undertakings (including Banks) any other organization should bring a "No Objection Certificate" issued from their Employer, in absence of which their candidature will not be considered.
3. Your candidature for the post has been considered based on the following eligibility criteria specified in the advertisement:-

"You are a citizen of India. You have passed a Bachelor Degree or its equivalent of a Recognized University in any discipline. You have proficiency in local language i.e. Hindi/Sanskrit. Your educational qualification, age, etc., conform to the eligibility criteria as on 01.06.2012.

Language Proficiency - Candidates are required to possess proficiency in the Official Language of the State/UT in which RRB is located and must have passed " local language" as one of the subjects at Matriculation/Xth Standard"
4. If at any stage of the recruitment, and thereafter, it is found that you did not fulfill the eligibility criteria as on the aforesaid date or furnished any false information, your candidature will be cancelled.
5. **You are advised to note that if selected, you will be required to execute a bond of Rs. 1,00,000/- with surety for serving the Bank for a minimum period of Three years and in the event of your resignation from the post before the expiry of this period you must indemnify and refund to the Bank the said amount of the indemnity bond. The indemnity bond is to be executed by the finally selected candidates before joining the Bank.**
